What's New at the APA

- APA elections concluded with members choosing Rebecca Brendel, M.D., J.D. to serve as the
 next President-Elect of the association. Dr. Brendel is an APA Distinguished Fellow and the
 current chair of APA's Ethics Committee. Her term as APA President-Elect will begin at the
 conclusion of the APA Annual Meeting in May. The results are not official until confirmed by the

- APA issued a statement urging state public health authorities to include people with serious mental illness (SMI) and substance use disorders (SUD) in the local equivalent of the Centers for Disease Control and Prevention's Phase 1-C. vaccine prioritization schedule. March Course of the Month - Buprenorphine Update and Evolving Standards of Care

This course will describe recent changes in the epidemiology of opioid use disorder, including the current epidemic of fentanyl, carfentanil, and other fentanyl analogs. The course will review: 1) recent regulatory changes and their effect on clinical practice and collaborative care models, 2) the results of research studies comparing buprenorphine and extended-release naltrexone, 3) the impact of new medication formulations, including injectable buprenorphine, 4) evolving standards of care for medication-assisted treatment including models for the management of opioid overdose and the efforts to reduce or eliminate barriers to admission to long-term medication treatment, and 5) plans to expand access to evidence-based treatment within the justice system.
